Abstract

The Widdicomb Company records include correspondence, papers, account books, a few photographs and miscellaneous materials of the various companies associated with the Grand Rapids, Michigan based Widdicomb family furniture companies from 1858 to 1954. Included are at least one item associated with the companies George Widdicomb & Sons (1857-1863), Widdicomb Brothers & Richards Co. (1869-1873), Widdicomb Furniture Co. (1873-1950), Widdicomb Mantel Company(1893-1897), Widdicomb-Mueller Corp.(1950-1960) and John Widdicomb Company(1897-2002). In addition, there are some records pertaining to the Halladay Lumber Co., of which Harry Widdicomb was part-owner. For 145 years, the Widdicomb name has been recognized in the furniture world. The earliest Widdicomb company was organized in 1857, by George Widdicomb, a British trained cabinet maker, employing 12 men, plus his four sons Harry, William, George Jr., and John. Except during the Civil War, a Widdicomb furniture firm was run by the family until 1916. The John Widdicomb Co. was founded in 1897 when John left the parent company to form his own firm. Though he died in 1910, that firm continued under his name until the 1990's, and purchased the title of the original company in the 1970's. The papers in this collection illustrate every day business of the various companies from 1865 to 1951.

Also, 6 large volumes are unboxed, wrapped in bubble wrap. These are currently numbered [5], [6], [7], [8], [9], [15]

Several boxes from this collection are on the oversized shelves.

Reboxing note, 2/13/2007

Item found smashed down in boxes due to extra space and wrong sized boxes. Some oversized items from old boxes 7 & 8 moved to clam shell boxes. Several others boxes consolidated, to free shelf space. Legal sized materials moved to Box 16. Empty Box 4 removed from the box list.

Processing note:

Folders were originally assigned chronologically for the entire collection, which often leads to problems when reboxing is desired later. Reboxing has been done selectively to better protect materials and to consolidate to conserve shelf space. Box and folder numbers changed for the materials rehoused, with some box and folder numbers not reused. 2/13/2007

Business books were ordered chronologically.

Additional processing needs

- Microfilming priority.
- Correspondence appears to be not always in order as described, and should be completely prepared before microfilming.
- Deteriorating conditions Box 32 Box is too big, and is to be replaced when better fitting box is available.
- The standard boxes are mostly old blue legal which are no longer acid free, and have torn white plastic handles.
- Several legal boxes have only letter sized materials or legal and letter.
- The boxes with window labels, which weakens the box structurally, should also be reboxed in the future.

History

From 1857 until 2002 the Widdicomb name was synonymous with Grand Rapids furniture making. The first Widdicomb firm was a cabinet shop, George Widdicomb & Sons, and was started in 1857 by the British trained cabinet maker, along with his sons, William, Harry, John & George, Jr. At the outbreak of the Civil War all four sons enlisted, leaving the father to carry on the business, which struggled along precariously until it expired in 1864.

In 1865 the oldest two boys (William and George Jr.) came home and started a small shop near the foot of the East Side Canal. At the close of the war Harry and John returned and became associated with them. All four were skilled craftsmen and possessed a thorough practical knowledge on the making of furniture. On January 1, 1869, Theodore F. Richards bought into the business and the company became known as Widdicomb Brothers & Richards, composed of William, Harry, and John Widdicomb (George Jr. having died in March, 1866), and T. F. Richards. The firm quickly gained a reputation as one of the finest manufacturers of bedroom furniture.

On December 1, 1873, the company was incorporated with \$150,000 and became known as the Widdicomb Furniture Company. The officers of that company were: William Widdicomb, President; T. F. Richards, Vice President; John Widdicomb, Secretary; and Harry Widdicomb, Treasurer. In addition, the brothers were each in charge of separate departments, William having the office management, Harry the power plant problems and John being factory superintendent. The company was located on the corner of Fourth Street and the Grand Rapids & Indiana Railroad tracks, which afforded adequate transportation facilities. Overall, they had about 150 men on their payroll, turning out approximately \$80,000 worth of goods annually.

In 1883 William Widdicomb retired from the company to accept the position of Cashier in the Grand Rapids National Bank, but in 1894 he returned to the furniture industry. In 1897 he was made president of the company with Roger W. Butterfield as vice president, Roger W. Griswold, secretary and George R. Widdicomb, treasurer (son of ?).

In 1893, the Widdicomb Mantel Company had been established, and with the restructuring of the parent company in 1897, John Widdicomb took this company as the basis of his own new company, the John Widdicomb Co. He started his own plant across the street from the original Widdicomb Furniture Company. It continued under his direction until his death in 1910.

On January 1, 1916, the original family owned Widdicomb Furniture Co. was sold to Joseph G. Griswold, Maynard A. Guest, Godfrey Von Platen, Heber W. Curtis, and Chalmer Curtis. The Widdicombs severed their connection with the company with which they had been identified since 1865, but the name was preserved. The officers of that company were: Joseph Griswold, president; Heber W. Curtis, vice president; Maynard A. Guest, secretary; and Godfrey Von Platen, treasurer.

History continued ...

When John Widdicomb died in 1910, the tradition for quality and fine design was carried on by his son Harry Jr., and their successors with the continuing reputation for making fine furniture products. John L. Stuart and J. Fred Lyon, both of who purchased an interest in the firm, joined Burt A. Hathaway, part owner of the firm, in the 1920's. In 1930 Mr. John L. Stuart was the company's sales manager; in 1939 he became general manager and shortly after that, he became president.

Ralph Widdicombe, a nephew of John who retained the old English spelling of his name, had earlier become interested in the designing of furniture, and when his uncle branched out for himself, Ralph joined him. For 53 years, until his retirement in 1951, Ralph Widdicomb, who was known as the dean of furniture designers, designed all John Widdicomb Co. furniture. Although Ralph is remembered best for his classical designs, it was his modern turn-of-the-century bedroom suite that was awarded first prize at the Paris Exposition in 1900. In 1924, working from models he had procured in Europe, Ralph Widdicombe introduced Louis XV Provincial designs, the first of their kind to be made in the United States. He started a wave of popularity for French Provincial, which still continues. A bombe bureau, the first such design, is still a much sought after pattern in John Widdicomb collection today.

In 1950, John Widdicomb Co. acquired the famous William A. Berkey Co., another old established maker of fine quality English furniture, and Vanderley Bros. in 1951. The Grand Rapids Bookcase and Chair Co. of Hastings, Michigan, was added to its holdings in 1956, but was latter sold.

In July of 1969, Furniture Corp. of America purchased John Widdicomb Furniture Co. In 1964 when Stuart was made chairman of the board, John D. Hanink had been named president of the company. He and his team of officers included: vice presidents, John W. Shockley and Gordon Stuart, son-in-law and son of John Stuart who died in 1966; treasurer, Allen D. Benson, and secretary and counsel, F. William Hutchinson.

The "Widdicomb" name, shared by the two manufacturers since John left the firm in 1897, was brought together again in November 1970 when John Widdicomb Co. purchased the name and goodwill of the Widdicomb Furniture Co., the latter having ceased production several years previously:

In February, 1973, the company was sold to Hickory Furniture Co. of North Carolina; it was operated as a wholly-owned subsidiary. There were no changes made in the administrative level of the company; Hanink kept the president office. Overall, the company was operated as a subsidiary of the Hickory Company.

History continued ...

On September 5, 1986, three men with commercial furniture backgrounds (Michael S. Greengard, David Miller and Michael L. Levitas) and a group of investors bought the 128-year old company from Hickory Furniture Co. The Widdicomb investors each own one-sixth of the firm. Greengard was considered the President of the Co. Other partners and their positions include Miller, vice president of operations; Levitas, vice president of marketing; David Zagaroli, an independent furniture designer and consultant and designer for Widdicomb; and Gerald Mason, a Grand Rapids businessman who helped organize the investor's group.

The company, located at 601 Fifth Street NW, still produces the top-of-the-line residential furniture, but is also expanding in the area of executive office furniture.

The papers and records portray the economic history of the Widdicomb furniture business. The audit reports, account records, cash books, ledgers, business invoices and transactions, and financial statements illustrate the every day business proceedings of the companies from 1865 to 1951. The business correspondences and other papers show the personal and professional side of how the companies were operated. The collection also contains check receipts, by-laws of the John Widdicomb Co., time book, trial balance, day book, maps of timber holdings, cutting order records, mortgage bonds, cash journal, purchase journal, passbooks to Stockings Second Addition-city of Grand Rapids, lumber sales by company and individual, historical notes, and portraits. Photographs pertain to the companies. Miscellaneous materials include autograph cards, papers pertaining to Edwin Widdicomb, Practical Book-Keeping Key, Mantel Designs Book, and letters pertaining to the Widdicomb Furniture Co. and John Widdicomb.

The John Widdicomb Company, closely woven with family history and harmony, is recognized for its rich heritage in the manufacture of exquisite furniture products. For 128 years the specialties of the company included chamber suits, chiffoniers, bedsteads, and bedroom furniture in quarter oak, ash, birch, and maple.

Scope and Content

Nine cubic feet of papers and records pertain to Widdicomb Furniture Co., while eight cubic feet of papers and records pertain to John Widdicomb Co. The Halladay Lumber Co. series contains one cubic feet of records. The papers and records cover 1854 to 1951.

On December 1, 1873, the Widdicomb Furniture Co. was incorporated, and John Widdicomb Co. was incorporated in 1897. In 1970 John Widdicomb Co. purchased the Widdicomb Furniture Co. name.

A majority of the invoices pertain to John when he was with Widdicomb Furniture Co.

The collection consists of five series, Historical Notes, Portraits, Papers and Records of the Widdicomb Furniture Co., Papers and Records of the John Widdicomb Co., and Records of the Halladay Lumber Co. In addition, it consists of sub-series: audit reports, business correspondence, account books, business invoices, business transactions, cash book, cash journal, day book, financial statements, ledgers, mortgage bonds, purchase journal, stock receipts, correspondence (John Widdicomb-Jacques Kahn, and John Widdicomb-Uptegrove & Bros.), by-laws of the John Widdicomb Co., church charities correspondence, check receipts, cutting order records, time book, trial balance, maps of timber holdings, passbooks to Stockings Second Addition-city of Grand Rapids, lumber sales by company and individual, and miscellaneous.

The papers and records of the Widdicomb Furniture Co., and John Widdicomb Co. are most valuable for tracing the economic history of their businesses. These series provide the debits, credits, cash or notes receivable, financial expenditures, and statements of transactions showing the everyday business proceedings of the companies. Basically, the everyday business proceedings of the companies from 1865 to 1951 are provided through the sub-series: account books, cash books, cash journals, business transactions, financial statements, ledgers, trial balances, and day books. The business correspondences include letters from customers, suppliers, transporters, and stockholders. The collection also portrays the human side of the furniture companies. The church charity correspondence consists of letters pertaining to donations made by the companies to the churches in the format of furniture. Overall, these series provide an understanding of how the Widdicomb companies were operated, how they treated their customers and suppliers and vice versa, and their involvement in the community.

Series Descriptions

Series I. Historical Notes & Oral History Box 1, folders 1 – 2.

Arranged chronologically.

Describes the history of the Widdicomb family and their furniture business. In addition, there is a tape cassette of an oral interview done by Gordon Olson (city historian of Grand Rapids) with John Widdicomb. This interview contains information pertaining to the history of the family business, and the reasons why the John Widdicomb Co. wasn't successful in the later years.

Series II. Portraits Box 1, folders 3 - 7.

Arranged alphabetically.

Portraits of the family members (George, Harry, John, Ralph, and William).

See also the Photographs Series below.

Series III. Papers and Records - Widdicomb Furniture Company. Box 1 - 4, folders 8 - 25, and 15 volumes. Arranged alphabetically and chronologically.

This series is divided among the following sub-series A-J: business correspondence - John Widdicomb, account books, business invoices John Widdicomb, cash books, cash journal, ledgers, and mortgage bonds, purchase journal, stock receipts, and miscellaneous.

Subseries A. Business Correspondence - John Widdicomb (July 10, 1893 to December 25, 1897) consists of letters from customers with orders, letters pertaining to purchasing and transporting equipment, letters in regards to the purchasing of timber land, letters pertaining to purchasing of wood and lumber products, letters regarding the shipment of logs to the mill, and letters regarding the settlements of accounts. Most valuable for tracing the economic history of the Widdicomb Furniture Co. are the incoming and outgoing letters with Ashton and Grand Rapids mills of the Halladay Lumber Co., Fox Machine Company, Mahony, Harlan and Hollingsworth Company, Michigan Central Railroad Co., Grand Rapids and Indiana Railway Co., Mosely Folding Bath Tub Co., Belknap Wagon Company, Michigan Furniture Manufacturers Association, Connersville Furniture Co. of Indiana, and Foster Stevens and Co. In addition, there are letters from Robert M. Ferris and Mr. L. M. Bailey regarding freight charges, and letters regarding the purchase of Widdicomb Mantle Co. by the Massachusetts National Bank of Fitchburg, Massachusetts.

Subseries B. Account Books (1854 - 1876) consist of debit and credit with other companies, and transactions involving particular items. Most valuable in showing the company expenses and sales account.

Subseries C. Business Invoices - John Widdicomb (1890 - 1903) consist of business statements to Widdicomb Furniture Co. from companies with which they had accounts. Included in the list of said companies are: Butterfield and Keeney, Foster Stevens & Co., Weatherly & Pulte,

Widdicomb Mantle Co., Ocker & Ford Manufacturing Co., Fuller & Rice Lumber & Mfg. Co., E.G.D. Holden & Son (Insurance Co.), Church & West Morton House Pharmacy, E. Kilstrom Coal and Wood, Palace Livery Co., Hutchinson & Haynes Practical Horse Shoes, Edgar S. Morse, E. B. Moore & Co., Jacob Herrman (Mason Contractor), and Fox Machine Co. In addition, there are invoices with groceries, cemeteries, tailor shops, horse stables, and other misc. businesses. A majority of the invoices pertain to John when he was with Widdicomb Furniture Co. However, there are a few invoices that pertain to his work at his own firm.

Subseries D. Cash Books (1880 - 1899) consist of records pertaining to cash receipts and disbursements.

Series III. Papers and Records - Widdicomb Furniture Company continued ...

Subseries E. Cash Journal (1872 - 1897) similar to cash books, it consists of records pertaining to cash receipts and disbursements. It covers business transactions that could not be recorded in specialized journals.

Subseries F. Ledgers (1872 to 1899) consist of records that summarize the company accounts. Most valuable in tracing the company's business transactions with other companies. There are headings for each company in the ledger, arranged alphabetically.

Subseries G. Mortgage Bonds (1893 to 1901) consists of series of bonds which pertain to the company's payments to its trustee, or bearer, Michigan Trust Company.

Subseries H. Purchase Journal (1916 to 1926) - Monthly records pertaining to the expenses of the company. These are most valuable in tracing the expenses in the area of fuel, sales, hardware, repairs, freight, expense general, and expense factory.

Subseries I. Stock Receipts (1881) consists of John and Harry Widdicomb stock receipts from the Adams Graining and Decorating Co.

Subseries J. Miscellaneous. There is an index, arranged alphabetically by surname that pertains to the company; possibly it might be an index to the employees.

Series IV. Papers and Records - John Widdicomb Co. Boxes 5-20.

Arranged alphabetically and chronologically.

This series is divided among the following sub-series A-U : business correspondence - John Widdicomb, correspondence (John Widdicomb-Jacques Kahn, and John Widdicomb-Uptegrove & Bro.), business correspondence - Harry Widdicomb, church charities correspondence-John Widdicomb, personal correspondence-John Widdicomb., account books, audit reports, business invoices, by-laws of the John Widdicomb Co., cash book, check receipts, business transactions, cutting order records, financial statements, ledgers, minutes of the efficiency committee, time book, trial balance, maps of timber holdings, and a journal & passbooks to Stockings Second Addition-City of Grand Rapids.

Subseries A. Business Correspondence-John Widdicomb (January 5, 1898 to February 9, 1910) consist of letters from customers with orders, letters pertaining to purchasing and transporting equipment, letters regarding the acquisition of timber property and warehouse property, letters pertaining to the court case of Frank Bellows, letters pertaining to the Paris Exposition of 1900, letters pertaining to the shipment of logs, and letters to the Board of Directors in regards to the destruction of Widdicomb Furniture Co. Warehouse No. 1. These letters portray the difficulties that the company was up against in the early years of operation. Most valuable in tracing the economic history of the company are the incoming and outgoing letters with Ashton Mill of the Halladay Lumber Co., Limuall, Bodley and Doolan Attorneys at law, Gustafsen & Olson (G6neral Merchandise), Grand Rapids & Indiana Railway Company, The Cobb-Buzzell Co., Charles Henry Davis, Board of Directors of the Widdicomb Furniture Co., Kent County Savings Bank, Conkling & Grovt Attorneys, Thayer, St. Rayner & Schabel Attorneys, Gunn Furniture Co., H. E. Scholle & Co., C. C. Chittenden Attorney at law, W. P. Williams (Manufacturer Agent), Studebaker Brothers Manufacturing Co., J. B. Van Sciuer Co., First State Savings Bank, and the United States Commission to the Paris Exposition of 1900.

Subseries B. Business Correspondence - Harry Widdicomb (December 21,1908 - October 23, 1950) consists of letters from customers with orders, letters pertaining to purchasing and transporting of logs, letters pertaining to the inspection of railroad freight cars, letters pertaining to the purchase of property and renting of freight yards, letters pertaining to stockholders, letters pertaining to the purchase and selling of timber land, and letters pertaining to the Tax History of the company. These letters help to portray the operation of the company while under Harry's leadership. Most valuable in tracing the economic history of the company are the incoming and outgoing letters with William Horner, Skillman Lumber Co., S. B. Ardis Land & Lumber Co., Mr. Claud Strickland, Mr. J. A. Morrell, Chas. Bennett Furniture Co., Travis Merrick, Warner and Johnson Attorneys, Mr. W. R. Brott, Standardized Furniture Co., Stow & Davis Furniture Co., Egbert Veneklasen, Citizens State Bank, U. S. Dept. of Agriculture, Hugh Shay Forest Products, Bromley Forest Agency, Bay De Novet Company, Connor Lumber and Land Co., and Richard A. Cross.

Subseries C. Correspondence: John Widdicomb - Jacques Kahn (January 14, 1897 to September 21, 1901) consists of incoming and outgoing letters in regards to the purchase and shipment of mirror plates. Most valuable in tracing the history of the company's account with Jacques Kahn.

Subseries D. Correspondence: John Widdicomb - Uptegrove & Bros. (June 27, 1896 to April 13, 1918) consists of incoming and outgoing letters in regards to the purchase and shipment of Mahogany lumber. Most valuable in tracing the history of the company's account with the Uptegrove & Bro. Co.

Subseries E. Church Charities Correspondence - John Widdicomb (January 3, 1903 to January 28, 1909) consist of letters regarding the company's charity work for churches. The company furnished several churches without any charge. Incoming and outgoing letters with Rev. John Forsberg of Traverse City, Mich., E. W. Jones of Harrietta, Michigan, W. H. Parsons of New Buffalo, Edwin W. Davis, and Robert Forbes of the Methodist Episcopal Church.

Subseries F. Personal Correspondence - John Widdicomb (October 27, 1902 to June 4, 1910) consists of incoming and outgoing letters pertaining to John Widdicomb, and the company. As well, there is a folder of sympathy letters from companies and friends of the family on the death of John. Most valuable are letters pertaining to the State of Michigan Supreme Court case of Peter W. Decker vs. John Widdicomb, letters regarding renting of cottages, letters regarding payments, letters pertaining to his involvement in the Republican party, letters pertaining to his appointment to the Board of Public Works of Grand Rapids, and letters pertaining to his protest of the Hepburn Bill. Incoming and outgoing letters include those-with Kappen, Kleinhans & Knappen, Pere Marquette Railroad Co., R. J. Horner & Co., Holson Motor Patents Co., O. B. Starkwather & Co., Harrison Wagon Co., Charlotte, Michigan Republican, and the Michigan Trust Company.

Subseries G. Account Books (January 4, 1905 to March 16, 1912) consist of debit and credit with other companies, and transactions involving particular items. These are valuable in showing the company's expenses and sales account.

Subseries H. Audit Reports (1910 - 1912) consists of reports that examine and verify the accounts and other records of the company at the end of the fiscal year. Most valuable in tracing the assets, liabilities, insurance, income, bills payable, loans, deduct cost of production, and merchandise purchase of the company.

Subseries I. Business Invoices (1899 to 1910) consist of business statements to John Widdicomb Co. from companies with which John Widdicomb Co. maintained accounts. Some of the companies included are: F. J. Dettenthaler, Reinders & De Hoag, E. D. Ellis, Palace Livery, Adolph Leitelt Iron Works, Knappen, Kleihans & Knappen, M. B. Wheeler Electric Co., Schneider Co., Fox Typewriters Co., Grand Rapids Gas Light Co., Baxter Co., Alden & Judson

Hardware Co., Peck Brothers Druggist, and etc.

Subseries J. Business Transactions (1922 to 1924) consist of records pertaining to Harry Widdicomb buying and selling of items.

Subseries K. By-laws of the John Widdicomb Co. (1897) consist of documents that describe the law under which the company was operated.

Subseries L. Cash Books (1897 - 1913) consist of records pertaining to cash receipts and disbursements. Most valuable in tracing the company's expenditures.

Subseries M. Check Receipts (1917 - 1922) consists of receipts acknowledging the company's payments.

Subseries N. Cutting Order Records (1897 to 1903) consist of records pertaining to the cutting of Oak, Birch Maple, Maple, Mahogany, and Toona.

Subseries O. Financial Statements (1907 - 1913) consist of records pertaining to the expenditures of the company.

Subseries P. Ledgers (1913 - 1914) consist of records that summarize the company accounts. Most valuable in tracing the company business transactions with other companies. There are headings for each company in the ledger.

Subseries Q. Minutes of the Efficiency Committee (June 14 - December 27, 1921) consist of official records regarding the transactions or proceedings made at the Efficiency Committee meetings.

Subseries R. Time Book (1917 - 1919) A book in which the hours of the workers are kept.

Subseries S. Trial Balance (1900 -1908) consist of listings of the debit and credit balances of all open accounts of the corporation. The listings are arranged chronologically.

Subseries T. Maps of timber holdings consist of maps pertaining to the timber land in the Upper Peninsula of Michigan.

NOTE: Series E-G are all in the same bound volume.

Subseries E. Cash Journal (1893 to 1908) similar to cash book, it consists of records pertaining to cash receipts and disbursements. It covers business transactions that could not be recorded in specialized journals.

Subseries F. Lumber Sales by Co. (1893 to 1912) consist of recorded sales according to companies, arranged in chronological order. Most valuable in tracing the sale of lumber to the Widdicomb Furniture Co., and John Widdicomb Co..

Subseries G. Lumber Sales by Individual (1893 to 1908) consist of recorded sales of lumber, according to individuals such as L.M. Cutcheon.

Subseries H. Ledgers (1893 - 1912) consist of records that summarize the company accounts with other companies.
